



**Peapack & Gladstone Art in the Park**  
**Sunday, September 17, 2017**  
**11:00am – 4:00pm**

Peapack & Gladstone's 'Art in the Park' is held at Liberty Park on Main Street in the picturesque town center of Peapack & Gladstone, New Jersey. Artists exhibit their work in a serene, outdoor park setting against a beautiful pond backdrop. *Art in the Park* began in 2000 and continues to grow in popularity with both exhibitors and attendees. Sponsored by the borough's Recreation Commission, the event is a showcase for a large variety of fine art and crafts, as well as an introduction to talented student artists. The event provides our patrons an opportunity to meet and talk with the individual artists. Live entertainment, food and beverage, and a children's craft area, make this a perfect day in the park!

**General Information**

No more than fifty (50) artists may attend the 2017 event. The number of artists exhibiting in each medium will be limited and the Recreation Commission reserves the right to deny an application if the maximum number of artists in a given medium already has been registered. All exhibited work must be 100% created by the artist or advertised vendor. Should the artist wish to use a tent, it must be clean and white and fit in the allotted **10' x 10'** space. Staging/display materials (tables, chairs, easels, etc...) are welcome, but must be supplied by the artist. **Only one artist will be allowed to exhibit in each 10' x 10' space.** Adjoining spaces may be requested for artists wishing to exhibit together. Artists must set up between 8:00 AM and 10:30 AM on September 17, 2017. The event will be held rain or shine and no refunds will be provided should an artist opt out due to weather conditions.

**Application and Fee**

A completed and signed *Application Form* and *Hold Harmless Waiver* are required to participate in *Art in the Park*. **A \$100 check (\$75 if paid before June 1), made payable to the Borough of Peapack & Gladstone, must accompany each application** (the entry fee is included). *For new artists only* -- please provide photos and a brief statement describing your work, or include your website address. If electricity is required, there will be an **additional \$100 fee** for 400 watts maximum.

**Application Deadline**

All applications, with the completed waiver form and payment, must be received by **August 1, 2017 (Early Bird registration deadline is June 1, 2017)**. Accepted artists will be notified by the Event Chairpersons no later than August 15, 2017. Maps with location assignments will be available the morning of the event.
