BOROUGH OF PEAPACK-GLADSTONE RECREATION COMMISSION WAIVER AND RELEASE

By registering my child for this program, I agree to the following:

In consideration for being allowed to participate in the above-described event sponsored by the Peapack-Gladstone Recreation Commission, I, if I am 18 years of age or older, to the greatest extent allowed under New Jersey law and with full knowledge, hereby waive, release and discharge any and all rights on claims, which I have or which may hereafter accrue, for myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest against the Borough of Peapack-Gladstone, its Recreation Department, and its respective agents, employees, public officials and/or volunteers ("Released Parties") which may arise directly or indirectly from my participation in the above-referenced event, including but not limited to my travel to and from the event. I fully and forever release, waive and discharge all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known, unknown, anticipated or unanticipated against the Released Parties even if caused by the Released Parties negligence in whole or in part. The term "damages" includes, but is not limited to, medical expenses, losses incurred as a result of bodily injuries or property damage, and/or personal property damages.

If this event involves participation in a sport, I acknowledge that sporting activities are inherently dangerous. I realize the dangers of participating in the event and fully assume the risks associated with such participation, including the possibility of serious physical and/or mental trauma or injury or death. I have no physical or medical condition which would endanger myself or others if I participate in this event, or would interfere with my ability to safely participate in the event.

I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM ASSUMING RISKS, AND AGREEING TO INDEMNIFY, NOT TO SUE, AND RELEASE FROM LIABILITY THE BOROUGH OF PEAPACK-GLADSTONE, ITS RECREATION COMMISSION AND ITS RESPECTIVE AGENTS, EMPLOYEES, PUBLIC OFFICIALS AND/OR VOLUNTEERS, AND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS. THIS RELEASE IS A CONTRACT WITH LEGAL AND BINDING CONSEQUENCES AND IT APPLIES TO ALL ACTIVITIES THAT ARE PART OF THE EVENT DESCRIBED ABOVE.
