TITLE: RESOLUTION AUTHORIZING AGREEMENT BETWEEN THE BOROUGH OF PEAPACK & GLADSTONE AND WARREN BLUE RIDGE SPORTSMAN FOR HUNTING RIGHTS LICENSE ON PUBLIC PROPERY FOR THE PURPOSE OF DEER CULLING FROM SEPTEMBER 13, 2025 TO FEBRUARY 21, 2026

NOW, THEREFORE BE IT RESOLVED, the Borough does hereby grant to Warren Blue Ridge Sportsman the exclusive license and right to use the Burdened Public Lands for recreational, non-commercial hunting of White-Tail deer with all legal archery equipment permitted in the State of New Jersey (including cross bow) as may be found upon and harvested from the following licensed areas:

DPW Yard at 12 Brook St. Komline Park Schoolhouse Trail Park Gateway Park

NOW THEREFORE BE IT FURTHER RESOLVED, the hunting will only be permitted on the Public Lands on Mondays, Fridays and Saturdays from one half hour before sunrise until one half hour after sunset. In the event of a conflict between the resolution and the agreement, the terms of the agreement shall control.

BE IT FURTHER RESOLVED, the Governing Body of the Borough of Peapack & Gladstone, County of Somerset, State of New Jersey authorizes the Mayor to sign the attached agreement for the hunting of White-Tailed deer on Borough Property from September 13, 2025 to February 21, 2026.

TITLE: RESOLUTION RECOGNIZING THE INCREASE OF THE BID THRESHOLD TO \$53,000 PURSUANT TO STATE LAW

WHEREAS, the State of New Jersey, through the Division of Local Government Services, has increased the bid threshold for contracting units that have appointed a Qualified Purchasing Agent (QPA) from \$44,000 to \$53,000, effective August 19, 2025, in accordance with N.J.S.A. 40A:11-3 and N.J.A.C. 5:34-5.4; and

WHEREAS, the Borough of Peapack and Gladstone has appointed Michael Pitts, CPA, CMFO, CTC, QPA, MPA, MBA as its Qualified Purchasing Agent, in full compliance with the requirements of N.J.A.C. 5:34-5 et seq., thereby authorizing the Borough to utilize the maximum statutory bid threshold; and

WHEREAS, this updated threshold allows for more efficient procurement procedures while maintaining transparency, fiscal responsibility, and compliance with the Local Public Contracts Law;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of Peapack and Gladstone Borough, County of Somerset, State of New Jersey, as follows:

- 1. Adoption of State-Authorized Threshold: Borough of Peapack and Gladstone hereby acknowledges and adopts the revised bid threshold of \$53,000 as authorized by the State of New Jersey, effective August 19, 2025, pursuant to N.J.S.A. 40A:11-3 and N.J.A.C. 5:34-5.4.
- 2. Qualified Purchasing Agent Confirmation: The Borough confirms that Michael Pitts, CPA, CMFO, CTC, QPA, MPA, MBA, is duly appointed and certified as the Borough's Qualified Purchasing Agent and shall continue to exercise the authority granted under the Local Public Contracts Law.
- 3. Direction to Departments: All Borough departments and officials are directed to adhere to the updated threshold in all procurement activities governed by the Local Public Contracts Law.
- 4. Effective Date: This resolution shall take effect immediately upon adoption and, if required, be filed with the Division of Local Government Services.

WHEREAS, the total amount of emergency appropriations created including the appropriation to be created by this resolution is \$90,000.00 and three percent of the total operating appropriations in the budget for 2025 is \$181,160.22; and

WHEREAS, the foregoing appropriation, together with prior appropriations, does not exceed three percent of the total current operating appropriations (including utility operating appropriations) in the budget for 2025;

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body, of the Borough of Peapack and Gladstone, County of Somerset, State of New Jersey, (not less than two-thirds of all the members thereof affirmatively concurring) that in accordance with N.J.S.A. 40A:4-48:

- 1. An emergency appropriation be and the same is hereby made for Air Conditioning in the Police Department and Main Electrical Panel in Borough Hall in the amount of \$90,000.00.
- 2. That said emergency appropriation shall be provided for in full in the 2025 budget and is requested to be excluded from CAPS pursuant to N.J.S.A. 40A:4-45.3.c(1)
- 3. That two certified copies of this resolution be filed with the Director of Local Government Services.

TITLE: RESOLUTION AUTHORIZING THE BOROUGH'S POLICE DEPARTMENT TO PARTICIPATE IN A "ROAD TO ZERO ENFORCEMENT" EFFORT FOR THE MONTH OF AUGUST 2025

WHEREAS, the Somerset County Prosecutors Office is offering to the Police Department a grant for "Road to Zero Enforcement" effort targeting serious moving violations which is being run by Highway Traffic Safety; and

WHEREAS, the purpose of this enforcement is to correct driver behavior and choices with the end result of lowering the crash rate and reducing the number of serious and fatal motor vehicle crashes that have been occurring; and

WHEREAS, enforcement will occur throughout Somerset County on certain dates and between certain hours only. Each week a new date and time will be assigned; and

WHEREAS, the Police Department can possibly be assigned 4 hours per week at \$70.00 per hour for a total of approximately \$1,120.00; and

WHEREAS, the Borough of Peapack and Gladstone Police Department wishes to take advantage of this campaign.
