ORDINANCE NO. 1156-2025

AN ORDINANCE DISBANDING THE LIBRARY ADVISORY COMMITTEE AND REPEALING CHAPTER 2, SECTION 47 OF THE MUNICIPAL CODE OF THE BOROUGH OF PEAPACK AND GLADSTONE

WHEREAS, the Borough Council of the Borough of Peapack and Gladstone has determined that it is in the best interests of the Borough to disband the Library Advisory Committee, as created under Chapter 2, Section 47 of the Revised General Ordinances of the Borough of Peapack and Gladstone; and

WHEREAS, the Borough Council finds that the organization of the Library Advisory Committee is no longer required and should be repealed from the Borough's codified ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Peapack and Gladstone, Somerset County, State of New Jersey, as follows:

- **SECTION 1.** Chapter 2, Section 47, of the Revised General Ordinances of the Borough of Peapack and Gladstone, titled "Library Advisory Committee," is hereby repealed in its entirety.
- **SECTION 2.** Following the effective date of this ordinance, Chapter 2, Section 47, of the Borough Code shall be designated as [RESERVED].
- **SECTION 3.** The Library Advisory Committee for the Borough of Peapack and Gladstone is hereby disbanded.
- **SECTION 4.** If any section, subsection, paragraph, sentence, clause, or phrase of this ordinance is for any reason found to be unconstitutional or unenforceable, such decision shall not affect the remaining provisions of this ordinance.
- **SECTION 5.** All ordinances or parts of ordinances of the Borough of Peapack & Gladstone which are inconsistent herewith are hereby repealed to the extent of such inconsistency.
- **SECTION 6.** This ordinance shall take effect upon final passage and publication thereof as provided by law.
