**WHEREAS**, the Mayor and Borough Council of the Borough of Peapack and Gladstone have determined that there is a need to appropriate certain monies for acquisition of Rescue Fire Truck for the Borough of Peapack & Gladstone Volunteer Fire Department; and

WHEREAS, on July 20, 2021, Ordinance 1102-2021 appropriated \$406,000.00 from the Capital Improvement Fund towards the purchase of a Rescue Fire Truck; and

**WHEREAS,** on February 8, 2022, Ordinance 1108-2022 appropriated \$250,000.00 from the Capital Improvement Fund towards the purchase of a Rescue Fire Truck.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Peapack & Gladstone, County of Somerset, State of New Jersey that there is hereby appropriated the following monies to be funded up to \$75,000.00 from the Capital Improvement Fund (CIF) and the remainder from lending and grants
