**AN ORDINANCE AMENDING CAPITAL ORDINANCE 1123-2023 FINALLY ADOPTED ON JUNE 13, 2023, IN AND BY THE BOROUGH OF PEAPACK & GLADSTONE, IN THE COUNTY OF SOMERSET, STATE OF NEW JERSEY TO APPROPRIATE \$40,000.00 FOR 700 Mhz TRUNKING RADIOS FOR FIRE DEPARTMENT**

**BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF PEAPACK AND GLADSTONE, IN THE COUNTY OF SOMERSET, NEW JERSEY AS FOLLOWS:**

**Section 1** The Borough Council of the Borough of Peapack & Gladstone, in the County of Somerset, State of New Jersey finally adopted Capital Ordinance 1123-2023 on June 13, 2023 to appropriate the amount of \$479,001.00 in the General Capital Fund, to the extent of \$424,201.00 from the Capital Improvement Fund and \$54,800.00 from the Open Space and Recreation Trust Fund.

**Section 2** The improvement hereby authorized and the several purposes from Ordinance 1123-2023 (a) through (j) and (k) \$40,000.00 700 Mhz Trunking Radios for Fire Department needs to be added in order for the totals from the Capital Improvement Fund and Open Space and Recreation Trust Fund are fulfilled.

All work shall be performed according to plans and specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.

**Section 3** The expenditure of the additional \$40,000.00 for the purposes set forth in Section 2 hereof are hereby authorized and approved. The total amount of the purposes is hereby authorized and approved. The total amount provided in Ordinance 1123-2023, as amended and supplemented, including by this ordinance

**Section 4** The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable, for the Borough. The capital or temporary capital budget, as applicable, of the Borough is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget of the Borough, a revised capital or temporary capital budget for the Borough has been filed with the Division of Local Government Services.

**Section 5** Except as expressly amended hereby, Ordinance 1123-2023 shall remain in full force and effect.

**Section 6** This Ordinance shall take effect immediately after final adoption as described in N.J.S.A. 40:49-2.
