TITLE: RESOLUTION AUTHORIZES THE APPOINTMENT OF AN INTERIM MUNICIPAL COURT ADMINISTRATOR FOR THE SHARED MUNICIPAL COURTS OF THE TOWNSHIP OF BEDMINSTER ("BEDMINSTER"), THE BOROUGH OF PEAPACK AND GLADSTONE ("PEAPACK-GLADSTONE"), THE BOROUGH OF BERNARDSVILLE ("BERNARDSVILLE") AND THE TOWNSHIP OF BERNARDS ("BERNARDS")

WHEREAS, due to the pending retirement of Teresa Van Allen, Certified Municipal Court Administrator of the Shared Municipal Court on March 31, 2023, there will be a vacancy in the Court Administrator position; and

WHEREAS, there is the need for a full-time Certified Court Administrator to manage the day-to-day operations of the shared municipal court; and

WHEREAS, the interview panel consisting of the Vicinage 13 Division Manager, Shared Municipal Court Judge, Township Administrator, current Shared Municipal Court Administrator and Human Resources; and Assignment Judge Kevin Shanahan of the Superior Court of New Jersey – Vicinage 13, recommends the appointment of Deputy Court Administrator Daniela Cordero as Interim Court Administrator; and

WHEREAS, Daniela Cordero is considered an interim Municipal Court Administrator pursuant to N.J.S.A. 2B:12-11(e) since she does not hold a municipal court administrator certificate; and

WHEREAS, the statute allows the governing body to appoint a person as a Municipal Court Administrator, on an interim basis, for a period not to exceed one year commencing on the date of the appointment; and

WHEREAS, the statute further states, "Any person so appointed may, in consultation with the judge of the municipal court, be reappointed as a municipal court administrator, on an interim basis, for two subsequent one-year terms. The municipal court administrator appointed on an interim basis may be reappointed for a fourth, and if necessary, a fifth additional one-year term, provided the municipal court administrator is currently enrolled in the certification program and needs additional time to complete that program".

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Bedminster, and as the host municipality and providing the services described in the Shared Services Agreement 2023-2025, that Daniela Cordero be appointed to the position of Interim Court Administrator for a one-year term commencing April 1, 2023, at the annual salary of \$80,000.

BE IT FURTHER RESOLVED that Daniela Cordero, upon successful completion of the Certified Municipal Court Administrator program, during her one-year term commencing April 1, 2023, and apart from any unforeseen delays, her annual salary will be increased by \$5,000 to \$85,000 annually.

BE IT FURTHER RESOLVED that the Shared Municipal Court Services Advisory Committee (SMCSAC) has reviewed and unanimously concurs with the terms and the appointment of Daniela Cordero as Interim Court Administrator for the Shared Municipal Courts of Bedminster, Peapack-Gladstone, Bernardsville, and Peapack-Gladstone Borough.

WHEREAS the Borough Engineer and the Director of Public Works have prepared a 2023 Stormwater Grant application for submission to the NJ Department of Environmental Protection (DEP); and

WHEREAS the application is for the Borough to develop a Stormwater Infrastructure Map which must comply with the requirements listed in Part IV. G. 1. A. of the Tier A MS4 Permit as outlined in the Notice of Funding Availability; and

WHEREAS the governing body of the Borough of Peapack and Gladstone, having considered this matter and the recommendation of the Borough Engineer and Stormwater Program Coordinator has determined it to be in the best interests of the residents of the Borough of Peapack and Gladstone for the Borough to seek grant monies for costs associated with the development of a Stormwater Infrastructure Map for the Borough.
