ORDINANCE NO. 1143-2024

PROVIDING FOR VARIOUS IMPROVEMENTS IN AND BY THE BOROUGH OF PEAPACK AND GLADSTONE, IN THE COUNTY OF SOMERSET, NEW JERSEY, AND APPROPRIATING \$600,000.00 IN THE GENERAL CAPITAL FUND, \$312,560.00 IN THE OPEN SPACE TRUST AND \$253,850.00 IN THE SEWER CAPITAL FUND THEREFORE FROM VARIOUS FUNDS OF THE BOROUGH

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF PEAPACK AND GLADSTONE, IN THE COUNTY OF SOMERSET, NEW JERSEY AS FOLLOWS:

Section 1 The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by the Borough of Peapack and Gladstone, in the County of Somerset, New Jersey. For the said improvement or purpose stated in said Section 2, there is hereby appropriated the sum of \$1,166,410.00 in the General Capital Fund, to the extent of \$600,000.00 from the Capital Improvement Fund, (CIF) \$312,560.00 from the Open Space and Recreation Trust Fund (OSRTF) and \$253,850.00 from the Sewer Capital Fund (SCF).

Section 2 The improvement hereby authorized and the several purposes for the financing of which the appropriation is made as provided in Section 1 of this Ordinance are as follows:

- (a) \$157,600.00 (CIF) the improvement of various roads including but not limited to Mosle Rd., St. Bernards Rd. and Brynwood in and by the Borough. Said Improvement shall include reconstruction, surfacing or resurfacing the roadway to the extent of Class B construction, together with studies, curbing, structures, storm water drainage, catch basins, milling, equipment, work and materials necessary therefore or incidental thereto
- (b) \$160,000.00 (CIF) Municipal Building Roof- Phase 1-Library
- (c) \$193,900.00 (CIF) Emergency Services Equipment (Fire Truck/Radios)
- (d) \$38,000.00 (CIF) Bed Replacement for Sterling (#3)
- (e) \$30,000.00 (CIF) Main Street Crosswalk
- (f) \$20,500.00 (CIF) Server Upgrade (Municipal & PD)
- (g) \$300,000.00 (OSRTF) Tennis Courts
- (h) \$8,760.00 (OSRTF) Geese Remediation
- (i) \$3,800.00 (OSRTF) Highland Ave. Trail Engineering
- (j) \$16,850.00 (SCF) 4x1 Bucket Attachment
- (k) \$50,000.00 (SCF) Manhole & Pipe Lining
- (I) \$187,000.00 (SCF) Treatment Facility Upgrade- Borough Portion

All work shall be performed according to plans and specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.

Section 3 The Capital Budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

Section 4 This ordinance shall take effect after final adoption, as provided by law.

WHEREAS, the Highlands Act specifies that conformance with the Regional Master Plan (Plan Conformance) requires revisions to municipal and county master plans and development regulations as applicable to the development and use of land to align them with the goals, requirements, and provisions of the Regional Master Plan; and

WHEREAS, the Borough of Peapack and Gladstone lies entirely within the Planning Area of the Highlands Region as defined by the Highlands Act; and

WHEREAS, the Borough Governing Body of the Borough of Peapack and Gladstone believes that it is in the best interest of the Borough to conform to the Regional Master Plan.

NOW, THEREFORE BE IT RESOLVED, that the Borough Council of the Borough of Peapack Gladstone hereby provides the Highlands Council with this Notice of Intent to petition the Highlands Council for Plan Conformance for all lands lying within the Planning Area.

BE IT FURTHER RESOLVED, this Notice of Intent is not binding with respect to lands within the Highlands Planning Area as provided for by the Highlands Act.

TITLE: RESOLUTION FOR EXECUTION OF AGREEMENT FOR PROVISION OF ELECTRICITY GENERATION SUPPLY SERVICES BETWEEN THE BOROUGH OF PEAPACK & GLADSTONE AND IDT ENERGY, INC. LICENSE # ESL-0081

WHEREAS, pursuant to New Jersey's Government Energy Aggregation Act of 2003 (N.J.S.A. 48:3-92 – N.J.S.A. 48:3-95 and the New Jersey Board of Public Utilities ("BPU") implementing regulations (N.J.A.C. 14:4-1 et seq.), as amended (collectively, the "Act"), the Municipality has determined to undertake a Residential Governmental Energy Aggregation Program (as defined herein) charged with the responsibility for adopting and providing for the implementation of such Residential Governmental Energy Aggregation Program within the geographic boundaries of the Municipality ("Program"); and

WHEREAS, pursuant to the Program, the Municipality's Council will enter into a written contract for the provision of Electricity Generation Supply Service on behalf of residential customers within its geographic boundaries which will replace such customers current default electricity basic generation service ("BGS") provided through the local electric distribution utility; and

WHEREAS, on October 8, 2019, the Municipality's Council adopted an ordinance formalizing its intent to commence the Program on behalf of all of the residential energy customers of the Municipality that do not opt-out of the Program in accordance with the Act and pursuant to the Act; and

WHEREAS, the Municipality and its duly appointed Energy Agents as defined in the Agreement engaged in a procurement process to obtain a third-party supplier of energy, duly licensed by the BPU, to implement the Program; and

WHEREAS, on April 22, 2024, the Municipality issued a Request for Proposals ("RFP") for Third-Party Energy Supplier pursuant to the Act; and

WHEREAS, based upon the Supplier's response to the RFP, dated May 6, 2024, the Municipality has determined that the Supplier possesses the minimum acceptable financial, technical and administrative qualifications including, but not limited to, any and all required authorizations to operate within the JCP&L Local Distribution Area, necessary to provide energy supply services, and thereafter designated the Supplier as a qualified vendor; and WHEREAS, after the Municipality's evaluation of all of the proposals submitted by qualified vendors in response to the RFP, has determined that the Supplier's proposal serves the interests of the Municipality and has resolved to recommend award of a contract for such services to the Supplier; and

WHEREAS, the Municipality and the Supplier now desire to enter into this Agreement for the supply of electricity generation supply services all in accordance with the terms and conditions of the Act, the RFP and this agreement.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Peapack & Gladstone, in the County of Somerset and State of New Jersey hereby authorize the Mayor to execute the attached agreement for the supply of electricity generation supply services all in accordance with the terms and conditions of the Act, the RFP and this agreement
