WHEREAS, the Borough of Peapack and Gladstone wishes to obtain professional consulting services from Princeton Hydro for a 2023 Regular Visual Dam Inspection, at Liberty Park Pond Dam, NJDEP File No. 25-302, Borough of Peapack and Gladstone, Somerset County, New Jersey; and

WHEREAS, the NJ State Department of Environmental Protection (DEP) requires according to N.J.A.C. 7:20-1.11 (e) Class III dams have a Regular Inspection performed every four years; and

**WHEREAS,** the last inspection of the Liberty Park Pond Dam was in April of 2019, therefore an inspection and report is due to the DEP at this time.
