Mayor's appointment, with the advice and consent of Council, of Louis Palma to the Municipal Alliance, term expiring December 31, 2016.

Mayor's reappointment, with the advice and consent of Council, of Greg Morris to the Agricultural Advisory Committee, term expiring December 31, 2018.

The Mayor and Council accepted, with regret, a resignation from the Historic Preservation Commission from Ed Edelson.

Mayor's appointment, with the advice and consent of Council, of Sujin Beckerman to the Recreation Commission, term expiring December 31, 2016.

Mayor's appointment, with the advice and consent of Council, of Sama Habibi to the Recreation Commission, term expiring December 31, 2016.

Councilman Corigliano asked whether the Council would like to move forward with a snow removal ordinance. Council discussed the issues involved and the need to confer with Borough emergency services. No action was taken at this time.

Councilman Corigliano reported the IT Committee will review the idea of developing a Mayor and Council blog.

Councilman Corigliano stated that at the February 9, 2016, Council meeting, a Councilmember misspoke and made a statement that Council would not be enforcing a recently adopted ordinance regarding Borough vehicle use. Councilman Corigliano stated the Borough enforces all of its ordinances.

Councilman Smith advised that interviews are being conducted for the Clerk/Administrator position in the Borough and semi-final candidates have been identified.

Councilman Lemma reviewed his draft for an amendment of the vacation policy for Borough employees. Council directed Mr. Bruder to draft an ordinance to be introduced at the next future Council meeting.

Council had a brief discussion on the lack of recognition by the U.S. Postal Service of physical addresses of homes in the Peapack section of the Borough.

Councilman Lemma will review landlord registrations of rental properties with the Borough Clerk.

Council discussed looking into using an outside vendor to clean Borough trails and use the collected wood as the compensation. Mr. Bruder stated he will provide the necessary indemnification language before any contract is signed.

PUBLIC COMMENTS

Diane Close, Ridge Road, asked whether any Council members had attended the February 19, 2016, New Jersey Transportation meeting. No Council member had attended. Ms. Close stated that some residents will not approve of a snow removal ordinance. Ms. Close feels that a blog is a good idea to increase communication.

Pia Hamlin, Holland Avenue, thanked the Council for all of its efforts. She suggested the formation of a small business association and the Mayor asked her to contact him for further discussion. Ms. Hamlin asked about the Borough policy for removing snow from in front of businesses in the Borough.

Ron Hill, Old Chester Road, stated that there is a problem with overcrowding in rental units in the Borough.

Louis Palma, Valley View Avenue, shared that Bernards Township recently decided not to pursue a show removal ordinance.

A RESOLUTION GRANTING FINAL APPROVAL OF THE VILLA APPLICATION TO SELL DEVELOPMENT EASEMENT

WHEREAS, the Borough of Peapack & Gladstone submitted a Planning Incentive Grant (PIG) Application to the State Agriculture Development Committee pursuant to the State Agriculture Retention and Development Act, N.J.S.A. 4:1C-11 *et seq.*, the Planning Incentive Grant Program, N.J.S.A. 4:1C-43.1 *et seq.*, and the regulations thereunder; and

WHEREAS, the application provided for the proposed acquisition of a Development Easement on property owned and / or contracted to be owned by Nicholas Villa and known as Block 26, Lots 16.08 and a portion of Lot 16.02; and

WHEREAS, the State Agriculture Development Committee certified the fair market value (CMV) of the aforementioned development easement pursuant to N.J.A.C. 2:76-7.14 at \$28,000 per acre (for an approximate total of \$720,160); and

WHEREAS, the landowner has accepted the Borough's offer of \$28,000 per acre for an approximate total of \$720,160; and

WHEREAS, the estimated cost sharing breakdown for the acquisition of the development easement is as follows (based on an estimated $25.72\pm$ net eligible acres), subject to the actual acreage to be covered by the development easement per the final survey which conforms to the farmland preservation program requirements:

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Peapack & Gladstone that it hereby gives final approval to the proposed acquisition of a development easement to be held by the County of Somerset on the Bluebird Farm, Block 26, Lots 16.08 and a portion of Lot 16.02 in the Borough of Peapack & Gladstone, County of Somerset, State of New Jersey, on approximately 28 acres pursuant to the County's Planning Incentive Grant application subject to the following:

1. The conveyance of a development easement which shall provide for the following:

- a. One 1.5 acre non-severable exception area which contains one (1) existing single family residential unit;
- b. One 1 acre non-severable exception area;

- c. Owner of premises shall be permitted to build one (1) additional single family residential unit of no more than 2,000 square feet of heated living space on one of the above-referenced exception areas.
- d. No dwelling units on premises as described in Schedule A of the Standard Deed of Easement;
- e. No non-agricultural uses;
- f. No Residual Dwelling Site Opportunities.

IT IS FURTHER RESOLVED that this resolution be sent to the Somerset County Agriculture Development Board, Somerset County Board of Chosen Freeholders and to the State Agriculture Development Committee for their final approval;

FINAL APPROVAL and ACCEPTANCE of this application is contingent upon the approval and acceptance of the County of Somerset and the State Agriculture Development Committee.
