7. PUBLIC COMMENTS: 5 MINUTES PER PERSON - NON-AGENDA ITEMS

It is the policy of the Borough Council that all public comments on an issue shall be limited to five (5) minutes per person. Comments may be made on any Non-Agenda subject pertaining to Borough issues. Comments pertaining to Public Hearings should be saved for that section of the agenda. No debating between residents. Rob Walton, with JCP&L, advised the Council that the company will institute a rate increase of about \$5.60 monthly per household. Receptacles for outdoor lights should be available for use for municipal decorations by the end of September. Administrator Gregory was directed by Council to look into the pricing of outlets.

Garvin Walsh recapped the Liberty Park Association meeting. September 13th, tentatively, has been set as the date to invite candidates to tour the park and listen to the LPA presentation. Councilman Lemma inquired about the \$71,000 cost presented by the Property Committee. The allotted five minutes to each speaker elapsed, though Mr. Walsh continued. Mr. Walsh proceeded to inform Council that the capital allocation is not realistic. Councilman Caminiti asked Mr. Walsh if he understood that the intent was to do fact finding and information gathering without commitment from Council. Mr. Walsh agreed that that was the plan. The Administrator requested that the Borough Attorney look at the RFQ, and Council concurred. Councilman Simpson reiterated Councilman Lemma's point regarding the dollar amount for the project. Mayor Muller made a proposal to sit down with Mr. Walsh, Property, and the Administrator.

Councilman Suriano noted that the main thrust was the preservation of the pond, but nothing was mentioned about a water feature. It was expressed that we should look into the removal of the pond. Councilman Lemma was concerned about the LPA selecting those who could participate in the RFP. Councilman Caminiti concurred with Councilman Lemma, but does not see the urgency to move forward.

Councilman Suriano asked what decision has been made, and the Administrator responded that the document was going to the attorney for review. Mr. Walsh asked the Administrator what document was going to the Borough Attorney, and the Administrator replied that it was the RFQ and his proposal. Administrator noted that the RFP is an open process and the Borough cannot prequalify bidders. Further discussion ensued.

John Kappler recommended looking at a long term plan for maintenance of the park. A subcommittee with Administrator Gregory will work with the scope of the design. A meeting with the Mayor and Property regarding the pond and the Park will be scheduled.

Public Works Director McCatharn stated that if we do not do something soon we will have to spend about \$8,000 to repair the road to make it suitable for the winter. Discussion ensued

It was determined that the money must be expended by May 17, 2017, which is two years after the award.
