

MAYOR & COUNCIL THE BOROUGH OF PEAPACK & GLADSTONE, BOROUGH COUNCIL MEETING MINUTES March 14, 2023



The regular meeting of the Mayor and Council of the Borough of Peapack & Gladstone was held on Monday March 14, 2023 at the Municipal Complex, 1 School Street, Peapack, New Jersey and virtually via GoTo Meetings and began at 7:02p.m.

Mayor Corigliano called the meeting to order. Borough Deputy Registrar Suzie Givone read the Sunshine Notice: "Pursuant to the Open Public Meetings Act, Adequate notice of 2023 Meeting Dates was published in the Courier News and Bernardsville News on December 8, 2022 and posted at the Municipal Complex and the Borough Library. Action may be taken."

Mayor Corigliano led the Pledge of Allegiance.

Roll Call indicated the following present: Councilwoman Dietrich, Councilwoman Murphy, Council President Sweeney, Councilwoman Weible and Mayor Corigliano.

Absent: Councilman Quartello and Councilman Lemma

Also present were: Mr. John Bruder, Esq., Borough Attorney and Nancy A. Bretzger, Borough Clerk/Administrator, Deputy Registrar, Suzie Givone.

PUBLIC COMMENTS - 5 MINUTES PER PERSON - NON-AGENDA ITEMS

Salvatore Arpino, 28 Pottersville Road, asked if the Council could address the speeding issues on Pottersville Road. He would like them to facilitate permanent speed signs.

Mayor Corigliano stated this is a county road so Peapack has very little jurisdiction on that road.

Sgt. Scanlon pointed out that Holland Ave is a county road and they do have their sign out there. He thinks Mr. Arpino is looking for the council to purchase another permanent solar powered sign that could be placed on Pottersville Road.

Council President Sweeney wants to explore other options such as striping the road before they invest into a sign.

Councilwoman Murphy will talk to Chief Ferrante about this issue and see if we can put a temporary sign out or rotate the signs. We will try some other tactics first.

OLD BUSINESS

Virtual Meeting Session (GOTO meeting)- This was postponed due to not all the council members being present.

NEW BUSINESS

Upcoming DEP Flood Plain Management Ordinance. The ordinance will be introduced at a later meeting and it replaces an existing ordinance. It deals with flood plain management for the stream and the river that run through Peapack.

The state has changed their laws regarding this so the Borough will need to update the ordinance to comply with these changes. Engineer Bill Ryden was on the phone and stated that he has no issues on the changes to the ordinance.

John Bruder stated that he agrees with Bill and does not see anything alarming. We are mandated to pass this. They will take a closer look at DEP's comments to make sure there are not any concerns. If we introduce it at the next meeting, there is still time to fit into DEP's timeline.

New website. Councilwoman Weible explained the reason for looking into a new website. The one we currently have is outdated. The backend is especially time consuming. It is practice to update your website every 5 to 7 years. The company we are looking at does websites for other municipalities in the area and their system is well vetted. This change will also help the public navigate the website easier.

The new website will be through SDL and as the Borough already have their construction and OPRA software, there should not be any problems integrating things.

Banking Relationship Change. In January the Finance Committee pursued exploring other Banking options and the Borough put out RFP's to 8 banks. Four banks responded and Councilman Eric Quartello complied the results. The Committee is down to two finalists and they will meet with these two and render a final recommendation.
